The filled-up nomination paper duly verified by the principal should be deposited in the sealed box kept in the Room No. 2 on working days between 10.00 a.m. to 5.00 p.m. but in no case later than 3.00 p.m. on Tuesday, the 12th September, 2023 along with a Demand Draft of Rs. 500/- from any nationalized Bank in favor of the Principal, Bhagini Nivedita College and Rs. 10/- Affidavit from Notary Advocate.
- 5. Withdrawal will be permitted if it is submitted by the candidate in his/her writing and in person with copy of College/Department/Institution Identity Card. No withdrawal shall be allowed after 12.00 noon on Wednesday, the 13th September, 2023
