The filled-up nomination paper duly verified by the principal should be deposited in the sealed box kept in the Room No. 13 on working days between 10.00 a.m. to 5.00 p.m. but in no case later than 3.00 p.m. on Thursday, the 19th September, 2024 along with a Demand Draft of Rs. 500/- from any nationalized Bank in favor of the Principal, Bhagini Nivedita College and Rs. 10/- Affidavit from Notary Advocate.
- 5. Withdrawal will be permitted if it is submitted by the candidate in his/her writing and in person with copy of College/Department/Institution Identity Card. The withdrawal form may be downloaded from the college website. No withdrawal shall be allowed after 12.00 noon on Friday, the 20th September, 2024
